Opinion

We have examined the Reserve Account Report of MYKOBO, which comprise "Reserve Account Information" as at 21st January 2023:

- EURC: The EURo Coin (EURC) is an asset-backed stablecoin pegged 1=1 with the Euro fiat currency. EURC is issued by MYKOBO. EUR Coin ("EURC") in Circulation = 134,575.00 EURC
- The total fair value of EUR denominated assets held in segregated accounts are at least equal to the EURC in Circulation at the Report Date.
- Overall traded volume as at 24th January, 2023 is 215,880.76 EUR
